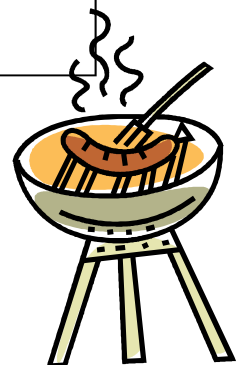

Free Japanese Willow Tree

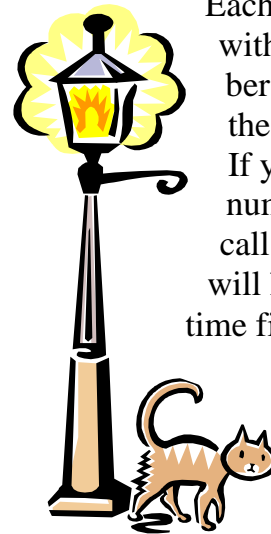
David Chang, the new owner at 8809 Copenhaver Drive, is offering the Japanese Willow Tree in his front yard to anyone in Copenhaver who would like it.

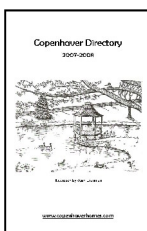

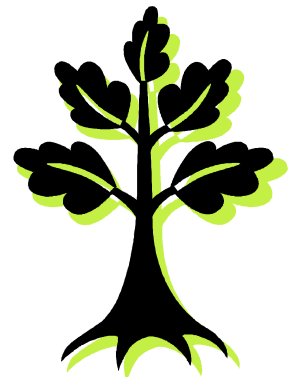
Bacterial Tree Scorch

Nearly all of the trees that line our streets are infected with Bacterial Tree Scorch and will die within the next 10 years. Although it is a fatal disease, pruning the dead limbs may extend the tree's life.

Please, continue to contact Brett Linkletter, the County Arborist about the county trees in your yard.

Once dead trees are removed planting new trees immediately will help Copenhaver to remain the tree lined beauty that we all love.
